**PRESENTATION**

**Bridges Out of Poverty, through St. Vincent de Paul- Manuel Rodriguez**

Thank-you for inviting us. Introductions of Cynthia Chavez, Suzanne Zombrano, Dennis Mummert, Nelly Olona. Discussed the overview of the program and the handouts which are attached hereto and made an integral part of these minutes by reference. Suzanne Zombrano spoke of how her husband died and she was left in poverty, this program has helped her. Nelly Orona spoke of how she was living in her car with her child and this program has really helped her to get a place to live and provide for her family.

Councilor Gallegos comments on his own family members that do not want to better themselves and asks the Bridges out of Poverty how to motivate those that do not wish to better themselves.

Cynthia Chavez comments that all participants are given a \$25 gift card (funded by the National Council) to those that show up for classes, so that they can buy food or clothing and learn how to better themselves. Additional money is provided to have lunch with participants as well. This serves as an incentive for the participants in hopes that they will learn to better themselves and get the resources that they might need to better themselves within our community.

#### **PUBLIC HEARING WITH POSSIBLE ACTION**

##### **Approval or Disapproval of the Revised Animal Ordinance. Presenter: Leona Vigil**

Over several workshops and meetings, last month workshop conducted with Chief Connor and ACO Vidal Torres. Sent to Attorney for review. Agreed with all of her recommendations. Added a few of our own: page 7, no permit fees for FFA, or educational animal programs. Page 8, added “or animal”, page 12 added “and/or”, Section B permits issues annually page 12, page 20 fees for impounding, we were currently paying the county but it will now read: “it shall be the responsibility of an animal owner redeeming an animal legally impounded under the provisions of this chapter.... The ACO shall establish appropriate procedures for collecting fees those who reclaim animals...” Chief Connor explained that we identified issues with that: before we were trying to determine fees for animals running at large, we pay the county to take care of the animals for us, and then the public has to pay the county to get the animals out. We fill it more appropriate for the citizen to pay ACO Vidal, he will issue a payment slip that they will present to the county so that the animal can be retrieved. \$25 for the first offense, \$50 for the second offense. On number 5: “any animal suspected of rabies shall be boarded at a regular rate plus \$6 special handling fee for all additional cost whichever is greater” We also added a kennel license, commercial license and a livestock permit-\$50 annually

Mayor Cordova asked for public comment on the issue, no one objected. Public hearing closed.

**Approval or Disapproval of the Revised Public(Utility) Services Ordinance. Presenter: Leona Vigil**

Came to the council several months ago, from tampering fees led into discussions of deposits, compared to other municipalities. Water rates committing meeting met a few times, came to a consensus of these rates. In our Municode right now Section 13-12-0-80 titled: "Tampering and damage to meter or city owned utility fees", we will no longer handle tampering, fee's penalty's to the police department. Will now read: "Tampering is when the account holder turns on a utility without authorization or "direct" connecting water service without a water meter, any individual caught tampering with a City meter and/or property will be referred to the Police Department for court proceedings, pursuant to a criminal damage to property charge. Appendix Rates and Fees, Title change from "Deposits for water and sewer service "to "Utility Deposits". Section A, meter deposits change: owner occupied stays at \$50, non-owner from \$160 to \$100 Commercial from \$300 to \$125 and remove the language "intuitional" Delete 13.12.080 police department to handle Damage to property. Reconnection of services due to delinquency changed the \$200 max to a flat rate of \$50.00 each offense.

Councilor Carter asked what happens to all the meter deposits currently on file in the fund. Are we refunding that \$70?(Leona answered no because when it was at \$90 and we moved it to \$120 we didn't have anyone come in and pay the difference)

Councilor Ortega and Gallegos both comment on the rate change to help economic development with lower rates and more citizens maybe wanting to live here. Further extensive discussion held on how this "helps citizens"

Mayor Cordova asked for public comment on the issue, no one objected. Public hearing closed.

City of Belen currently has a CDBG grant for the San Lorenzo/La Luz project, \$500, 000, we need a fiscal agent for this. Oversight of the money, 2.5%

**Approval or Disapproval of the Resolution Adopting and Approving Disclosure Compliance for Bonds and Loans.**

**Presenter: Katherine Creagan**

Discussion held regarding the Resolution adopting procedures for continuing disclosure related to outstanding bonds. When bonds are initially issued there is information that the market uses to determine whether or not to invest in the bonds. The securities and exchange commission has become very interested in issuers and really they regulate underwriters, they want to be sure that the City and issuers are keeping the information that is available to potential investors, fresh and up to date. What this resolution does is provides procedures for the City to keep the information out there up to date.

Councilor Carter asks what the avenue that is expected out of the City to disclose our finances, via website, letter to them directly, or in the paper?

Katherine: The dissemination of the information is through a site called EMMA, run by the MSRP, Municipal Securities Rulemaking Board, City uploads their audit yearly to it and certain events to it, in this instance the City had a rating upgrade you would upload information relating to the upgrade of the City’s bond rating or if you are redeeming bonds we also posted that on EMMA.IRB’s are generally not uploaded it would be disclosed in your audit, unless it’s a publicly marketed.

Councilor Carter asked Roseann is she is familiar with EMMA (Roseann answers no, that in January after the audit is approved from the State we submit the information to George K Baum, and they upload that information for us, audit report etc...)

**Approval or Disapproval of the Resolution Adopting and Approving Tax Procedures for Bonds and Loans. Presenter: Katherine Creagan**

Discussion held regarding the Resolution to approve tax procedures for bonds. Federal tax implications related to City bonds. Most public issuances, general obligation bonds, the gross receipts tax bonds are issued on a tax exempt basis. Because of the favorable tax treatment of the interest on the bonds the federal government, IRS is interested in how you spend the monies on the bonds, how you use the projects that you fund with bond proceeds, that you are not investing proceeds in a way that is allowing you to get arbitrage, earning more than your having to pay out. What these procedures will do is set in a place the mechanisms to keep track of how your using the facilities, how you’re investing the proceeds, whose keeping the records and that any changes are noted and there is continual review of the investment and the use of the proceeds. Nice to have these procedures in place for the City, for when we submit and information return to the IRS on there indicates a place to check a box weather the city has in place written procedures related to arbitrage. This avoids any red flags for audits.

Councilor Gallegos comments that these bonds were elected by the citizens for the fire station and sidewalk repair.

Councilor Carter questions the 2005 bonds and obligations to report on these that was used for infrastructure projects?

Katherine: The outstanding 2005 bonds will be redeemed tomorrow, on November 30 when the refunding bonds close, your 2008 bonds will be defeased,(no longer outstanding under the ordinance) you will continue to have obligations for disclosure and to be tracking how your using those infrastructure projects, until these refunding bonds will be paid off. There is a pledge in place of your municipal GRT and State share on those and that same pledge was carried over for your 2008 bonds and now these bonds, that same pledge is in place, it is not as though you releasing... (interrupted by Councilor Carter)....it is all the same revenue stream, what you have pledged you still have to keep in place and collect for the benefit of the bond holders

Roseann explains that it reverts to the original ordinance. The 2005 bond and the 2008 bond both had two separate portions of the municipal GRT that was pledged towards them to pay off the bonds, now that 2005 is going to be paid off completely, now it reverts back to the original ordinance where it says that that pledged revenue was collected for infrastructure and maintaining a water/wastewater and solid waste facilities. The 2008 that is now refunding and being refinanced to the 2016, whatever was pledged to pay that will now go to the 2016.

**Approval or Disapproval of the Inducement Resolution “Project Nick”. Presenter: Steve Tomita**

Inducement, IRB, Industrial Revenue Bond referred as “Project Nick” at this time as they do not want their name prematurely disclosed. Plastics manufacturing company, injection mold manufacturing outdoor furniture, storage units, shelving units, they are one of the largest in the world, \$2 billion a year, international company, most of their operations are over seas, one plant near Indianapolis, planning on having a total of 3 in the US, one in Central and in the West. If they do build the plant here, this will be their Western operation, presently competing Tuscan/Inland Port, Reno and their industrial park and someplace in California. California will be their largest market, but surprising enough we are on the top because of NM tax incentives and there is an existing building on the property, Solo Cup building. This company will use the Solo cup building will be used for warehousing and distribution. They will build another 80-100,000 sq. ft plant that will do the production, new standards are a minimum 45ft high ceilings. IRB, the City is not financially responsible it is up to the City and then the State to approve the issue of the bond. They will have to qualify for the bond through their financial statements. We will take possession of whatever is encumbered by the IRB and then their tax incentives that come back and other items will reimburse that bond over time. Offered to them was a 67% on the tax over 20 years. 100-200 hired people to start, hoping to achieve 300. They will be self-funded. October 18<sup>th</sup> came to look at the plant, prepared to make an offer over the next week or so. Depends on how fast we can get the IRB done, 90-120 days. Water consumption is 140, 000 gallons a month, fully automated system. Train rail is imperative to bring in the resins, taken into a tunnel system to the new plant to manufacture. Distributed out by truck.

Councilor Carter comments that IRB’s are reviewed by the State, by no means is the City of Belen doing any financial review here locally, all we are saying is support to looking at passing the IRB and support this business, predicated on

reviews and approvals by the State, and we are not pledging its assets or going to underwrite this bond. We are committed to support the building/reconstruction.

This we went over last meeting and Council approved for the comprehensive plan, that is on our ICIP. \$50,000 our match would be 10%, which is already budgeted. We are submitting a resolution to submit the application for the grant for the comprehensive plan.

**Approval or Disapproval of the TIP Resolution for Road Improvements. Presenter: Steve Tomita**

Will not be approving an actual TIP resolution tonight. Jay Ashbacher with Molzen/Corbin here to present the two options that have investigated, estimated costs of construction address the drainage concerns. There is not a resolution format that has been issued as of yet, from the State. Tonight we are only asking approval to submit the application. Two projects proposed was Aragon Road continuing West from Mesa Rd up to I-25, big concern council had concerning that is the flooding in that area, Molzen/Corbin looked at that, they will present a solution and the amounts on that. The other project was to continue Mesa Road, South of Camino del Llano down to Cannon Road. Both would implement paving, curb and gutter, sidewalk and any drainage that is now required to be complete when you go after these projects, they have to be complete projects. Funds are limited at this time for TIP for the whole rural, small projects to about \$5 million, we are very limited. Submittal is due on November 28, 2016.

Jay Ashbacher- Applications are complete, can be revised if you so decide. What I propose for West Aragon to pave, curb and gutter, sidewalks on both sides to meet ADA compliance, flooding, similar to West Delgado pond, looking at doing something similar to that. This is 5 years out, propose to do a retention pond there for the 2022-2023 year. Alleviate any flooding in that area, West Aragon road itself to retain water, to alleviate flooding there. \$1million to design (2022) and

construct(2023) Staggered so that we meet the DOT requirements, contingencies are accounted for, inflation, etc.. cost can go up. 15.56% match on a \$1million project, \$150,000.

Councilor Gallegos expresses concern about following the “same master plan” for the City on the drainage. Chief Manny Garcia and Molzen Corbin were to work on a Federal Grant for the pond on Aragon, we still have two on the mesa to be done, the Mae Reid pond. Please look into all the proper FEMA paperwork and time limits and constraint as there should be funding out there for this project already, mitigation funding. We want to make sure that we have more than one resource, avenue for funding for this project, in case one falls through.

Jay Ashbacher-2<sup>nd</sup> job is South Mesa, proposing to start from Morning Star to Cannon Road. Addressing paving, curb and gutter on both sides, 5ft sidewalk on the West side to match, multi-purpose path on the East side to continue with the continuity of Mesa and street lighting as well. Include the appropriate drainage improvements. \$1.5-\$2 million

Councilor Gallegos again questions where that street came from and if it is listed in the ICIP

Jay Ashbacher expresses that West Aragon is on the ICIP, can't remember if South Mesa Road is.

Councilor Gallegos again expresses that it should be on the ICIP. Further discussion lingers. Councilor Carter agrees to keep to roads ONLY on the ICIP

Steve Tomita expresses that the City is limited to “major collector Roads and higher” Belen doesn't have very many roads that meet that qualification, to even apply for this funding. We want to make sure that it is a large enough project to justify going through all that we have to, to comply with everything. That was the other reason that these two were selected at the previous November 7<sup>th</sup> meeting. We must indicate the projects when we apply for the funding. Applications came out very late from the State.

Mayor Cordova agrees to follow ICIP. Also suggests that Council make a motion to put one project as priority over the other, as the Aragon is on the ICIP and South Mesa is not.

Mayor Jerah Cordova asked for a motion. Councilor Carter motioned to approve the TIP Application for Aragon Road, Mesa Road going West to I-25. Mayor Cordova asked for a second. Councilor Gallegos seconds the motion.

**Approval or Disapproval of a Reallocation Budget Adjustment for the Municipal Environmental Services Gross Receipts Tax. Presenter: Roseann Peralta.**

Imposed on any person engaging in business here within the municipality is charged an excise tax equal to 1/16<sup>th</sup> of 1% of their GRT that is reported, this is known as the Municipal Environmental Services Gross Receipts Tax. That tax is collected and as per the ordinance the dedication for that tax is to be used for acquisition, construction, operation and maintenance of solid waste facilities, water facilities, waste water facilities and sewer systems and related facilities. Currently right now this revenue that is collected is being posted into the Solid Waste Fund. As we know, we have seen that the Solid Waste Fund has a large amount of money in it. It has enough to sustain itself, because we are shifting



towards Wastewater, permit almost done to start the renovation and expansion of the plant, I recommend diverting this tax over into Wastewater to start building up that fund. When we do get the funding for the renovations we will have a match, if not some other monies to go towards that renovation project. This is only a budget transfer and Resolution 2016-31 is attached hereto and made an integral part of these minutes by reference.

Councilor Carter and Leona commend Ms. Peralta for thinking ahead and getting ready for the future

Following up on last week's meeting, here to request a Sergeant position for the BPD in a attempt to combat crime. One Detective to assist Lt. Portillo with follow-up on cases. Currently we have Portillo as the only Detective in the PD. To help with budget constraints, Det. Sgt. thought up. This position would help Portillo 80% of the time the other % of the time will be utilized as the Patrol Sgt. when the other Sgt is unavailable. No immediate equipment needs associated with this position. Wanting to increase the squad from 21 to 22, conferred with Roseann, and we believe it would be sustainable to years to come. This position will have a modified schedule, 10:00 a.m. to 7:00 p.m. or noon till later in the evening. Monday thru Friday.

Councilor Aragon comments that the public is noticing the presence of the Police Force more in the community.

Councilor Gallegos encourages being creative with positions and vacancies, and grants for police officers

Chief Connor to look into further funding for Police Department, commented on 4 cadets that graduated, hope to be out on their own in January
