*Example: Repainted front end rear porch enclosed with decorative glass a protective portico in rear home and adobe and wire fence around the western and northern perimeters with decorative posts. Air conditioning added during the residence of the Baca family.* 

9. **Historical background**. Discuss events or persons associated with the property's original owner(s).

*Example: Original owner is the mother of a famous Belen educator and founder of the Belen National Guard.* 

10. **Sources of information.** Identify sources of information on the property and deed. *Example: Valencia County Assessor's office; daughter of original owner, Teressa Valdo. Check with property caretaker Adolfo Munoz.* 

11. **Photographs.** Submit recent photographs that show all sides of the property and its immediate setting and associated buildings structures or objects that may be included in a nomination. If available, send hard copies of older photographs of the property.

12. Location map. Submit a map of the property location, showing the relationship of the building to roads and/or other landmarks. *Example: Screen shot from* maps.google.com

13. Why this building should be designated an Historic Landmark. Give details of why this residence should be viewed as significant to the history of Belen, the State, and/or the Nation? *Example: Landmark preservation of a fine home from the 1930s characteristics of the Americanization Prairie-style architecture and the period due to the prompt opportunity to get building materials via the Santa Fe railroad and the bypass rail line.*
